REGULAR SESSION
MINUTES

The Pymatuning Valley Local Board of Education met in regular session on Monday, September 12, 2022 at 6:00 pm at the High School Lecture Room with the following members present: President Margaret Struna, Vice President Curt Harvey, Mrs. Jodie Hitchcock, Mr. Duane Marcy and Mr. Joshua Peyton.
